- Rooted in storytelling about ordinary people experiencing harm due to corrupt authoritarianism
- Solution-oriented, with a vision for a government truly accountable to the people that recognizes that-as we have argued for years-the status quo has been deeply flawed for a long time.

Grantmaking: RepresentUs Education Fund made grants to Represent.U.s to support public education, research, and cross-partisan outreach activities. Funds were also used to promote educational content about popular, smart political reforms; to produce compelling videos; and to provide of-the-moment communications on news items impacting our democracy. Grantmaking also underwrote the recruitment and training of volunteers.
